### SOUTH MAIN STREET BRIDGE AND PEDESTRIAN LINKAGE

### MUNICIPAL CLASS ENVIRONMENTAL ASSESSMENT STUDY

#### THE STUDY

The City of Thorold has retained McIntosh Perry Consulting Engineers Ltd. (McIntosh Perry) to provide consulting services for the concerns related to the South Main Street Bridge and Pedestrian Linkage in the Port Robinson area (map below). The purpose of this Notice is to announce the Study Commencement and to invite all those interested in the Study to engage in reviewing the issues and opportunities, as well as to provide input.

As per the Ontario Structural Inspection Manual bi-annual inspection, the existing South Main Street Bridge is in poor condition and has been closed for public use at this time. Therefore, the City of Thorold is undertaking study to address the need to provide a safe and reliable pedestrian linkage between South Main Street and Cross Street in the Port Robinson area.

#### THE PROCESS

The project is following the requirements of the Municipal Class Environmental Assessment (EA) process for a Schedule 'B' undertaking. During the study various technical studies will be conducted that will consider the associated impacts to the natural, cultural, socio-economic environments in the area, and identify the preferred alternative solution based on input through the study consultation activities. This will include input from agencies, affected groups, and the general public.

#### PUBLIC CONSULTATION

Public consultation is the vital to the success of this study. We want to ensure that anyone interested in this study has the opportunity to get involved and provide input. Any comments or questions can be directed to one of the following project team members at any time during this process and will be considered in identifying the preferred design alternative to address pedestrian linkage within the EA study area.
