1. Dasher Board Sponsorship - Eric D'Uva

As part of the base contract each rink dasher board includes 10 advertisement panels with poly carbonate recessed. You can also put advertising panel on top. Additional panels available at \$400 a piece pending material availability. This is time sensitive as the manufacturer needs to know where these 10 panels should be located by the end of the day. The Consortium agreed that for Rink 1 and 2, option B would be best as all the seating falls on one side. If there is video streaming, the location will allow for the ads to be seen. On Rink 2, Option B will be flipped as the seating is looking towards the benches and it will likely wrap in the corners due to the number of doors on that side.

2. Approval of Minutes - Nicole Wolfe

3. Monthly Progress Report – David Schram

See *UEM Monthly Report Canada Games Park 18 – June* document for full details. David Schram gave the following site progress updates:

- The fourth and final site tour is happening today, so far, they have been well attended.
- The preparation for the paving of the parking lot and access roads has been under way for 10 days, the base coat paving is supposed to start today.
- 6 storage SeaCans have been delivered and installed.
- Front street plaza concrete work has been on going for the past couple of weeks
- Interior work:
 - The gym ceiling painting has been completed; the painting of the arena 1 ceiling has started
 - All the level 2 spaces painted
 - The washroom tiling has begun
 - o Millwork for all the offices has been delivered but needs to be installed

Monthly Report 18 updates:

- Awaiting a schedule update, the last one was received on June 10th
- The December 1st goal for substantial competition is still in place.
 - Concerns raised about the wood flooring as curing of the concrete is essential, if the HVAC is not in place there could be issues. It was suggested not to push Aquicon and allow them to take the proper time they need to set and cure the flooring, but the schedule needs to be adjusted to reflect this additional time.
- Page 30 lists potential changes of significance.
- A quote for the exterior IT/AV facilities has been received see summary of IT changes under the owner requested cost section (page 40). Total for IT/AV owner requested changes at \$1.1-1.2 million total.
- Cash allowance is exceeded by \$10,000 since the initial budget alert in March. There
 is expected to be further costs which will total out to around \$25,000-30,000 dollars
 over the cash allowance budget.
